Future development must be approached holistically and the interests of all of the stakeholders need to be considered.</li> <li>- Future implications need to be considered alongside present needs before any demolition/destruction takes place.</li> <li>- Original design principals need to be understood before any changes/'improvements' are made, as these might still be applicable today.</li> <li>- Developers must create and maintain a hierarchy of development plans supported by important stakeholders. Arguments that led to these decisions must be documented.</li> <li>- Historical buildings could be preserved by putting them to productive use, new owners must be aware of the responsibilities that come with owning such buildings. Buildings which are accessible to the public could be reused to fill a need in the community. Previous "Examples of the application of this strategy included: converting the old post office for use by the Moths; the Club building for use by the local authority; 2 (?) These were iron and wood structures and one (a semi) is worthy of preservation (even though it has had structural modifications, it still retains its original appearance).</li> <li>- Houses built in 1933 for migrant artisans from Scotland (modeled on homes in Scotland) in an area that became known as Tiny Town. Some Cape Dutch style houses were also built in Ostend and Post Office around the same time. Some of these houses have retained the characteristics of the original designs and should be added to the list of buildings worthy of preservation.</li> <li>- Homes for managerial staff were also built in the early 1930's. Elm Avenue (between Park and Gardens) has many examples of houses where the facades (at least) are in their original state, examples can also be found on the Northern side of Myrtle Avenue, the southern side of Plane Avenue. Keith feels that Elm Avenue (as a whole), is worthy of preservation and should therefore be included in the study as such and that the houses on Myrtle and Plane should be assessed on an individual basis.</li> <li>- Modderfontein Village expanded further in the late 1940's when semis were built in Provan, Oak, Thornhill, Bruges and the extensions of Elm, Plane and Myrtle. A lot of the early infrastructure is still in its original state and later additions to both the residential area and plant are also still standing.</p> <p>Recent large scale sale and development of land in this previously 'protected' area means that a successful HIA is very important. MCS also see a HIA as being important in helping the Society to police this environment into the future.</p> <p>A previous study focused on the Gautrain project in order to protect houses built in 1896. One of the houses was saved and artifacts from the demolished house were used to restore this rescued house.</p> <p>Although the area to be surveyed includes the largest concentration of historical buildings outside of the factory area, concern has been raised that some important buildings to the north of this area have been excluded. These include the Laboratory, the Weather Station and General Offices. Singles quarters in McGowan Road were also excluded. There were also barbed wire fences and trenches intended to restrict the movement of the Boer troops.</p> <p>Story by Lenna Janicki Lenna grew up in Modderfontein, she lived for a while in a home (since demolished) in High St. "Several of the handsome and historic older houses in the High St area have also been beautifully restored and converted into small office complexes and of course, Franz Hoenig House is an excellent conference venue." The area between Dam 1 and 33 High St. is now informal parkland; the old Modderfontein Factory School and Scout Hut have been demolished.
